I want to take this opportunity to wish everyone a HAPPY NEW YEAR!! A lot has been happening since our last newsletter so let me bring you up to date with a few important items. Most recently we have installed a new slate of officers serving on our board. Also, listed on the website are the approved exterior items such as roof shingles, siding, lighting etc. Please remember to complete an ARB form and have it approved prior to making any exterior changes to your property.

The first Board Meeting was held January 11th where the new Officers were nominated and approved. The annual dues notifications were emailed around January 3rd. If you do not receive emails your HOA dues invoice will be included with your 2024 Neighborhood Directory that was attempted to be delivered in mid-January. Remember, all dues are to be paid in full by January 31, 2024. We appreciate your prompt payment so we can begin the new year fiscally sound.

In looking forward to the coming months weather always plays a key factor for our community. Therefore, if mother nature decides to bring us additional snow in the coming months you are reminded to clear your sidewalks either by coordinating with Legendary Landscaping or someone else if the need arises. The City of Salisbury snow removal policy states: "All property owners adjacent to any street within the City limits are responsible for the removal of snow from their sidewalks. The snow must be removed for the entire length of their property for a width of four feet. The removal must take place within six hours after the snow has stopped falling. If the snow stopped between the hours of 5 PM and 7 AM, then the snow needs to be removed before 2 PM."

In late 2023 The Board engaged MillerDodson Associates Capital Reserve Consultants to complete an HOA Capital Reserve Study to be in compliance with Maryland House Bill 107. The Consultants provided a preliminary copy to the Board on January 11th. The Board will review and discuss in detail at the February Board Meeting. Once finalized we will make more information available.
